On Brexit day, we still organized our European flagship conference in the United Kingdom. For the first time ever, we cancelled our founding conference at Yale University due to the pandemic, but replaced it with an online policy competition; we worked relentlessly on our first-ever book project with ASKO Europa-Stiftung; our chapters grew both in number and scope on all three continents. They organized events, conferences, and crafted their own policy memos. Not only did we persevere, but we showed that we, students, are resilient and committed to our values and ideals. Our vision, belief and hope for a better, more inclusive and connected world is tireless.

They listened to keynote speakers: Federica Mogherini, High Representative of the EU for Foreign Affairs and Security Policies, VP of the European Commission, and Japan's Defense minister Taro Kono.

TOULOUSE PUBLICATION

Despite COVID-19, the Toulouse chapter published an extensive booklet to conclude their ongoing research cycle on "Contemporary Turkey since the election of AKP in 2002." The articles discuss a variety of topics, ranging from the Syrian conflict to more domestic issues in Turkey, such as the Kurdish question. As part of this research cycle, they also produced a fact sheet tracing the key stages of Turkey's accession process to the European Union.

APRIL 2020

EUROPEAN STUDENT POLICY COMPETITION (ESPC)

European Horizons held its FIRST-EVER DIGITAL POLICY COMPETITION. The competition was organized to provide an alternative to students who were going to participate in the European Student Conference 2020, which was canceled due to COVID-19. For ESPC 2020, 20 PARTICIPANTS submitted their policy memos on various transatlantic and European issues, such as development of the transatlantic partnership and issues in cybersecurity and defense.

DIGITAL ECONOMY YOUTH SUMMIT (DEYS)

The day after the United Kingdom officially left the EU, European Horizons hosted 80+ STUDENTS from across the world for DEYS at Cambridge University. What is required for a sustainable economy? What are the policy implications of digital banking? How can transatlantic cooperation

better handle big data and CYBERSECURITY? Our students discussed and engaged with some of these questions, producing policy papers to be published and distributed to leading policymakers. Kristian Jensen, MP and fmr. Foreign Affairs and Finance Minister of Denmark, and Dr. Alexander Rodnyansky, Assistant Professor at Cambridge University and Chief Economic Adviser to the Prime Minister of Ukraine, touched on these ideas and the role of European Horizons as a CATALYST FOR CHANGE.

EUROPEAN FALL POLICY CONVENTION (EFPC)

European Horizons gathered 22 MEMBERS from Europe and Asia for EFPC in Otzenhausen, Germany. During this weekend, in the fall before Brexit and in the wake of a new European Commission and Parliament, members discussed the future of European Horizons. Is European Horizons a partisan organization? Are we more than European and transatlantic? How do we fully realize our potential as a POLICY INCUBATOR? The convention dove into important discussions over short- and long-term strategies, such as chapter operations and the overarching mission, and socializing between members from 13 countries. At the European Academy of Otzenhausen, a small German district with less than 2,000 inhabitants, about two hours from Frankfurt, some of European Horizons' leading members made life-long friendships and debated the VISION of a student-empowering policy incubator in the 21st century.


